YOUTH PARTICIPATED IN 36 WEEKS OF EVENING WORKSHOPS AND 30 WEEKEND ADVENTURES. WORKSHOP CURRICULUM FOCUSED ON A WIDE RANGE OF TOPICS INCLUDING TRUST, TEAMWORK, COMMUNICATION, COPING SKILLS, GOAL SETTING, INDEPENDENT LIVING SKILLS, AND ENVIRONMENTAL STEWARDSHIP.
